I - SPECIAL CONDITIONS

1 - PURPOSE OF THE PROCUREMENT

Sale of ONE (1) used vehicle from the Embassy, according to the Special Conditions and the Technical Specifications.

2. TENDER SPECIFICATIONS

It will not be required to submit bids, or to the admissibility of the same, or to hire, having removed this Bidding Terms and Conditions, however those who did not had retired or discharged may not plead ignorance of the actions that may have been produced until the day of

the bid opening, remaining under its responsibility to carry out the necessary knowledge to take those steps.

3 – EFFECTS OF BID SUBMISSION

Submissions of a bid implies full knowledge and acceptance of the rules and provisions this procurement and interpretation of its precise scope.

Bids may be submitted until the deadline for submission and from that moment will be inadmissible any change in the essence of the proposals.

4 - COMMUNICATION

The communications between the Embassy and the interested parties, bidders and successful bidder may be in person, by mail, by fax and by mail service.

5 - CONTENT OF THE OFFER

BID must be drafted in English

BID must be submitted in a sealed envelope or by e-mail to the only address,

BID must be expressed in local currency: Ringgit Malaysia

BID must be for a value higher than the base price

Before submission of a Bid, the bidder understand

The offer must contain the information detailed below:

Name and surname or company name, address, telephone, fax and email of the bidder, which will be valid all notifications made.

Constitution of domicile in (city / town of Representation).

If the offer was signed and submitted by a legal representative must attach a copy of the power of attorney or documents certifying the legal status of that representative to sign the proposal.

6. -EXHIBITION VEHICLE - DEFECTS

The vehicle offered by the Embassy will be displayed in place until the date and time indicated in the title of this specification.

Bidders acknowledge that they have had a chance to inspect the said well and if they decide tender without making the inspection do at your sole risk and therefore no claim may be made in relation to goods which were awarded him, with motifs of vices that may arise.

The bidders irrevocably renounce to invoke the guarantee for latent defects in relation to the goods under this contract.

7. SUBMISSION OF ENVELOPES AND OPENING OF BIDS

At the date and time established, the sealed envelopes will be submitted.

At the date and time indicated, bids will be opened in a public meeting, in the presence of officials designated for that purpose and all those wishing to witness it.

The authorized officer will review the evidence, proceeded to carve out a record of the bidders that will be enabled to participate in the auction.

8. VERBAL OUTBIDDING

In order to comply with the provisions of Article 173 inc c) of Decree 893/12, two (2) business days after the auction date and the set time reading the offers that are on will take place able to participate.

After the reading of the bidders will be invited to enhance its offerings through a verbal bid selection falling in that tender would be the highest value.

The result of the auction will proceed to draw up a certificate that will be signed by the presiding judges and bidders who desire to do.

9. VEHICLE EXPENSES

They will be paid entirely by the highest bidder transport costs, freight, hauling packs, and any other costs or expenses that requires the fulfillment of the contract for both vehicles. Also they will be responsible for the payment of the corresponding taxes, cost of office, duties and customs services, and any other encumbrances affecting the property acquired.

All costs of transfer of the vehicle given by the Embassy / Consulate form part of the price offered and borne solely by the co-contractor.

For this purpose the Embassy, will hand over the relevant documents to the latter initiating the procedures for transfer within the time limits specified in these Terms.

10. FINES

The vehicle offered by the Embassy is free of fines at the time of delivery, taking over the Embassy of the cancellation of the fines that may exist prior to the issuance of the sales order date.

11. DAMAGES AND COSTS

Once purchased and removed the vehicle offered by the Embassy, buyer will be solely responsible for any damage that is caused to third parties, and charge any cost to occur.

12. MAINTENANCE OF THE OFFER

Bidders must hold firm offers for a period of SEVEN (7) calendar days from the date of opening of bids.

13 – NON-AMENDABLE GROUNDS FOR BID DISMISSAL

Bids will be dismissed without possibility of cure, in the following cases:

- a) If it was not written in a language other than that established in the bidding terms and conditions.
- b) If the offer was not signed by the bidder or its legal representative.
- c) if he has erasures, scratches, or interline amendments without saving in the sheets containing the economic proposal, the description of the goods offered, delivery, or any other party who makes the essence of the contract.
- d) If the offer by the deadline remains more is not indicated in the tender.
- e) If it were written in pencil or with means for erasing and rewriting without a trace.
- f) If it is made by people who had a valid sanction of suspension or debarment from contracting with the Argentine State at the time of bid opening or at the stage of evaluation of those or the award.
- g) If it is made by natural or legal persons disqualified from government contracts Argentine when opening the bids or the evaluation stage of those or the award.
- h) If contained conditions.
- i) If contained clauses as opposed to the rules governing the hiring or prevented accurate comparison with other bids.
- j) When contain essential errors or omissions.
- k) If the price quoted deserved qualification vile or not serious.
- l) Bidders who are ineligible pursuant to the provisions of Article 86 of Decree No. 893/12.

m) If a single bidder is submitted in more than one bid either by itself or as part of a group, association or legal person. This prohibition is not configured in the case of tendering discounted, alternatives or variants.

14 - AWARD

The award for the offer, fulfilling all the requirements of these Terms prove the most suitable, taking into account both the quality and suitability of the bidder offering the highest price.

The award will be notified to the contractor and the other bidders, within FIVE (5) business days of the award process issued by any of the means mentioned in point of this terms and conditions.

COMMUNICATIONS.

Within ten (10) business days of notification of the award process sales order that the winner will be notified by the same means it will be issued.

15. TERM AND FORM OF DELIVERY

From receipt of the **sales order**, the successful bidder shall contact Embassy representative in order to make the necessary management procedures that allow the transfer of ownership of the vehicle.

Once the transfer will take up to fifteen (15) working for the removal of used vehicle days, the total delivery and in the condition you are.

The movement, loading, transport and media will be under the responsibility and by the buyer.

16. PLACE OF DELIVERY

The co-contractor is obliged to remove the vehicle offered by the Embassy.

17. PAYMENT

Payment shall be made after the receipt of the SALES ORDER, at which time the documents for the transferring of the vehicle will be made available to the buyer or compliance with the requirements of billing required by local regulations.

18. - TERMINATION OF CONTRACT

If the successful tenderer desist expressly or contract before the deadline for compliance, or if the expiration of the original performance of the contract, its length, or the deadline for the summons having been made, the contractor had not fulfilled under the contract, the Embassy shall declare terminated the contract without judicial or extrajudicial, except in cases where opt for accepting late fulfillment.

19 - LIABILITY

The co-contractor must comply with the legal rules applicable to the activity subject of the contract and will be responsible for all extrajudicial and judicial claims, including costs and expenses arising from their acts and omissions or those of his staff or subcontractors or others before him WHATSOEVER responsible for compliance with any of the terms and conditions of this contract.
